

# **HGSE Education Entrepreneurship Fellowship Program Application**

## **Application Guidance AY 2025-2026**

### **General Information**

The Harvard Graduate School of Education (HGSE) is very pleased to offer the Education Entrepreneurship Summer Fellowship. The purpose of this Fellowship is to provide funding for students and recent alumni to advance their entrepreneurial ventures during the months of June, July, and August. A limited number of fellowships will be awarded on a competitive basis. Ordinarily, award amounts will not exceed \$10,000 per venture. Proposals in the launch/start-up phase (as opposed to ventures that are in the ideation or scaling stage) will be prioritized.

### **Fellowship Eligibility**

- Current master's and doctoral students at HGSE.
- Recent HGSE alumni with a graduation date in November 2025.
- Future HGSE alumni with a pending graduation date by May 2026.
- Team applications may include active students from other Harvard schools, with an HGSE student as lead. If applying with co-applicants, please be aware that the award will be split evenly among the applicants.
- Funds may be utilized as stipends for team members, with no individual to receive a stipend in excess of \$2,500 per month for the months of June, July, and August.
- In addition to stipends, funds can be used for the general operating purposes of the venture, with all budgets subject to final approval.

### **Fellowship Requirements**

- Reflection reports of approximately 1,000 words will be due to the program administrators no later than October 1, 2026.
- Fellows agree to be interviewed and/or filmed to promote the program.
- Fellows may be asked to participate in entrepreneurship activities at HGSE during the 2026-2027 academic year.
- Applications are due February 23, 2026 at 5pm EST.

### **Selection Criteria**

- Demonstrated interest in, and commitment to, education entrepreneurship.
- Viability of the entrepreneurial venture and identified success measures.
- Potential impact of the entrepreneurial venture.
- Progress to date such that the summer will advance the mission and impact of the entrepreneurial endeavor.

**Please note, we cannot fund proposals for programs for a limited population if that group is based on a legally protected category (race, ethnicity, national origin, sex). However, proposals that are open and welcoming to all populations, but may be particularly beneficial or relevant to certain audiences, are permissible.**

A committee of HGSE faculty and administrators, with the opportunity for consultation with the I-Lab, will review applications and make fellowship selections.

7. How will this venture make a positive impact on the education sector? What challenge will it address? Please include data to support your assertion. What is your theory of action? Who is the target audience? (2500 character limit)
8. How will you measure the success of your venture when fully implemented? (1250 character limit)
9. What other programs/products are doing similar work in the field? What makes this different from what already exists in the field? (1250 character limit)
10. Please describe your target user as narrowly as possible. Who will pay for your product if there is a cost? If the user is not the same as the payer(s), please indicate who the payer(s) will be. (1250 character limit)
11. If you have a prototype/minimal viable product, please describe. (1250 character limit)
12. If you are selected for the fellowship, what are the three most important things you will accomplish during the summer? Please be specific and include a timeline. (1250 word limit)
